



## 2023 Golf Outing Contract

The undersigned in consideration of Cranston Country Club Inc. (hereinafter referred to as CCC) renting to us a portion of their facilities for the purpose and number of guests as outlined hereinafter agree to the terms and conditions set forth below:

FIRST : Initial \_\_\_\_\_

We will furnish CCC with a final count on the Monday prior to the outing. (If your event is scheduled for a Tuesday, a final count should be given no later than the prior Thursday.) We can change the final count to account for extra golfers up until 72 hours prior, but no more than a 10% increase over the final count. We understand that if the final count reduces the minimum count originally guaranteed, we will still be responsible to pay CCC for the said guaranteed minimum count.

SECOND: Initial \_\_\_\_\_

We agree to pay for the golf outing *prior* to the scheduled tee time. Payment for dinner is due after golf. Please have (2) checks available if you are having a banquet following golf.

THIRD: Initial \_\_\_\_\_

It is understood and agreed that patrons of this function will confine themselves to the room rented and will not interfere with other functions being held simultaneously whether member or outside.

FOURTH: Initial \_\_\_\_\_

***a) CCC will be responsible for deeming an appropriate banquet room according to the size of the outing and availability of banquet rooms.***

b) CCC reserves the right to cancel engagements at any time where the rules of the club are not observed or functions are not of the nature deemed acceptable by the club.

FIFTH: Initial \_\_\_\_\_

In accordance with Rhode Island Law and CCC's Alcohol Awareness Policy, no alcohol may be purchased or served to anyone under the age of 21. No alcoholic beverages may be brought onto the premises except those to be placed on the *beverage cart*. *The number of total alcoholic beverages brought onto the premises is not to exceed 2 per person*. Additional alcoholic beverages may be purchased from CCC. No alcoholic beverages may be removed from the premises. Courtesy beverages brought into the clubhouse or clubhouse area from the beverage hole is strictly prohibited. *CCC staff and management reserves the right to refuse to serve anyone believed to be intoxicated.*

**Coolers strictly prohibited!!!** There is a fee of \$100.00 for any event bringing in alcoholic beverages.

SIXTH: Initial \_\_\_\_\_

We assume all responsibility for any and all damage to the facility or for any personal injury to guests or employees of CCC caused by the acts, conduct, or omissions of the undersigned of their guests.

SEVENTH: Initial \_\_\_\_\_

All banquet prices are subject to a 20% service charge, 7% R.I. sales tax, and 1% R.I. Food and Beverage tax.

EIGHTH: Initial \_\_\_\_\_

We agree that if we broach this agreement and/or fail to pay any moneys due under the terms of this agreement, that we will pay to CCC all reasonable legal fees and court costs incurred by them to enforce any of the terms of this agreement.

NINTH: Initial \_\_\_\_\_

My signature and initials indicate that I have read, fully understand and intend to comply with all the policies and stipulations listed in the attached letter regarding golf outings held at Cranston Country Club.

TENTH: Initial \_\_\_\_\_

A non-refundable \$200 deposit payable by check or cash is required when reserving dates for golf outings. Said deposit will be deducted from the final golf bill the day of the event.

**GENERAL INFORMATION**

- All shotguns with fewer than 120 golfers *place two groups* on each tee beginning with the first hole. Groups with over 120 confirmed golfers would use all 18 holes of the golf course.
- Cranston CC provides volunteers with access to a maximum of 2 courtesy carts. Volunteers must be 18 yrs with a valid driver’s license, no exceptions.
- Events will register under the tent on the patio prior to teeing off.
- All proximities (closest to the pin, longest drive, and betting circles) can be supplied by CCC.
- A final, GUARANTEED, count is due five (5) days prior to the event. This is the number of people you are responsible for paying for prior to tee off.
- Rain Dates for events may be assigned but not until the day the event has been rained out. All events are expected to play unless the conditions are deemed unsafe or unplayable by CCC management.
